- Good verbal and written communication skills

Candidates for the At-Large Girl Delegate position must meet the following criteria:

- 1. Accept the principles, beliefs, and purpose of Girl Scouting.
- 2. Be a citizen of the U.S.A., as required by GSUSA Congressional Charter and Constitution.
- 3. Be a registered member of Girl Scouts.
- 4. Be a minimum of 14 years of age at the time of appointment.

Expectations:

- 1. As voting members, participate in the governance process of the corporation.
- 2. Attend the Annual Meeting of the corporation (on Saturday, April 22, 2023).
- 3. Contribute to committees or task forces of the corporation, as requested and if available, to serve as the voice of girl members by providing perspective into the needs and interests of today's girls.
